



MEMORANDUM OF UNDERSTANDING

BETWEEN

KOREAN CULTURAL CENTRE INDIA (KCCI)

AND

INDIAN INSTITUTE OF INFORMATION TECHNOLOGY SENAPATI, MANIPUR (IIITSM)

This Memorandum of Understanding (MOU) is entered by and between Korean Cultural Centre India, hereinafter referred to as "KCCI" with registered address at 25 A, Lajpat Nagar IV, New Delhi, India and Indian Institute of Information Technology Senapati, Manipur, hereinafter referred to as "IIITSM", with its address at Indian Institute of Information Technology Senapati, Manipur, Mantripukhri, Imphal, Manipur, India. KCCI and IIITSM are independently referred to as 'Party' and collectively as "Parties".

The Parties hereby agree to establish collaboration for jointly carrying out the tasks into broad spectrum of imparting hands on training in the field of Korean language, culture, placement and capacity building programmes for the students of Indian Institute of Information Technology Senapati, Manipur and especially the B.Tech and Ph. D. students. This MoU shall be treated as the platform on which both parties agree to work together in future. Accordingly, the terms and conditions binding in nature of this collaboration are set out in the following articles hereunder:

BACKGROUND

Korean Cultural Centre India is the Press & Culture Department of the Embassy of the Republic of Korea in New Delhi.

Indian Institute of Information Technology Senapati, Manipur (IIITSM) is an institution under Ministry of Education, Gov. of India. IIITSM was established in 2015 in order to develop Manipur as preferred destination for Information Technology (IT) related manpower and industry. This shall enable Manipur to gear up for providing IT related services as well as high-quality Research & Development in IT. IIITSM offers BTech in Computer Science and Engineering (CSE) & Electronics and Communication Engineering (ECE), and PhD in CSE, ECE and Humanities and Basic Sciences from its own campus located at Mantripukhri, Imphal.

Article 1. Purpose

The purpose of this MOU is to facilitate cooperation and establish a general framework between the Parties by jointly carrying out necessary tasks through mutual exchange and cooperation regarding Korean language and culture promotion as a future-oriented relationship between the Parties.

Article 2. Scope

- 1. This MOU shall be subject to mutual cooperation in relation to the works of the Parties.
- 2. The Parties recognize the mutual interest in the promotion of Korean language and culture, and strengthening its capacity and also employability skill development for the students of Indian Institute of Information Technology Senapati, Manipur.

Article 3. Details of MOU

Roles of the Parties are as follows:

Indian Institute of Information Technology Senapati, Manipur

- Provides a suitable place for education management such as classroom and other facilities, and manages and protects them.
- Supports systems required for promoting Korean language class- noticing for student enrollment and other operations.
- 3) Collects and handles tuition fee according to the guideline of the institute. Rs3,500 per student (to be revised from time to time) for two academic semesters (Total 90-hour program) will be deposited to the account of King Sejong Institute Imphal which is directly run by KCCI.

Korean Cultural Centre India

- 1) Administers and supervises operation of the Korean language class.
- 2) Provide Korean language teachers as well as programs related to Korean language education and culture through King Sejong Institute Imphal.
- 3) May support teaching materials and manpower for operating the class.

Article 4. Term of Validity

- 1) This MOU becomes effective upon being signed by the parties.
- 2) This MOU is valid from 10 November 2022 to 31 July 2023 upon being signed by the parties. However, the term is subject to the condition that King Sejong Institute Imphal is operated under the Agreement of Entrustment for King Sejong Institute in 2023.

Article 5. Intellectual Property

All promotional material which will be produced or used by any of the parties solely or in collaboration with each other, during the term of this MOU relating to the business of each of the Parties shall remain the sole property of each of them.

Article 6. Force Majeure

In the event of occurrence of an unforeseen Force Majeure or an event that renders either party incapable of fulfilling its duty, the party should notify the other and ask for suspension or cancellation of the affected items so that losses of the other party can be minimized.

Article 7. Miscellaneous

The Parties shall determine items not included in this MOU by mutual consultation. Such modification, change or update shall be in necessary written agreement and agreed by the Parties.

Further, the Head, Department of Humanities and Basic Sciences, Indian Institute of Information Technology Senapati, Manipur shall be the Nodal Officer for IIITSM to expedite the activities related to this MOU whereas as for KCCI the Director, King Sejong Institute Imphal shall be the Nodal Officer for future communication and other activities related to this MOU.
