MEMORANDUM FOR STUDENT EXCHANGE PROGRAM BETWEEN
INDIAN INSTITUTE OF INFORMATION TECHNOLOGY SENAPATI
AND

SRM INSTITUTE OF SCIENCE AND TECHNOLOGY (SRMIST)

The two Institution agree to exchange students under the following terms and conditions:

1. The Memorandum covers the exchange of Undergraduate, Post-graduate and Doctoral students. Hereinafter "exchange student" shall refer to a student participating in the Student Exchange Program implemented herein.
2. Exchange students shall not be liable for examination fees, registration fees and tuition fees at the host university and they will continue pay the fee to the respective home Institutions.
3. Exchange students shall be liable for all the expenses except the fees mentioned above.
4. The number of exchange students accepted by the host university shall not exceed 20 person at a given time in a year. The period of attendance at the host university for exchange students shall not exceed one year (two semesters).
5. Exchange students accepted by each university shall have the status of special undergraduate students/special graduate students/ special graduate students.
6. Exchange students shall possess language proficiency sufficient to comprehended lectures and conduct their research at the host university.
7. Upon students' request, each university can recognize the academic credits awarded or course work evaluated by the host university for its own exchange students, according to the criteria and procedure of the home university.
8. Each home university shall have the permission in advance from the host university when the home university select its own exchange student(s).

9. Exchange students shall be responsible for their medical insurance and other forms of personal insurance.

Supplementary Provision

1. This agreement shall be effective from 29th December 2022 and shall remain in force for a period of three years following this date. The validity of the Memorandum may be extended when mutually agreeable to both parties.
2. Amendments to and termination of the Memorandum must be performed by a written agreement between Indian Institute of Information Technology Senapati (IIIT)-Manipur and SRM Institute of Science and Technology (SRMIST), Chennai.


