



TECHNOLOGY DEVELOPMENT (TD) PROJECT GUIDELINES

Eligibility Criteria:

- 1. **Applicants (Principal Investigator (PI) and Co-PIs):** At least one of the applicants (PI or Co-PIs) must belong to a Scheduled Caste (SC) or Scheduled Tribe (ST).
- 2. **Academic Position:** Applicants must hold a regular academic position at the **IIIT Manipur**.
- 3. **Qualification:** The PI and Co-PIs must hold a Ph.D. degree in Engineering or Science.

Nature and Duration of Support:

- 1. **Scope of Support:** The TEXMiN-IIIT Manipur Mining CPS Centre of Excellence (CoE) will support individual researchers or research groups working exclusively at Host Institution.
- 2. **Project Duration:** The project duration is strictly two (02) years.
- 3. **Funding Limit:** The maximum funding provided for the entire project is ₹13 lakhs (Indian Rupees Thirteen Lakhs only).
- 4. **Proposal Limit:** An applicant may submit only one proposal per call as a PI.

Selection of Application:

Selection will be based on the recommendations of a Program Advisory Committee constituted by the competent authority (Head of the Institute).

Plagiarism:

- 1. Submitted proposals must present original ideas and content.
- 2. Plagiarism in any form will not be tolerated.
- 3. All proposals will undergo a similarity check, and any found to be plagiarized will be rejected.
