a) Master's degree in Engineering/Technology in the relevant area with a minimum 60 % marks (or CGPA of 6.0 in 10-point scale or equivalent) both in the Bachelor's and Master's degrees (In case of SC/ST/ Differently abled candidates CGPA/CPI 5.5 or 55% of marks).

OR

b) Four-year Bachelor's degree in Engineering /Technology or equivalent in a relevant area with a minimum 80 % marks (or CGPA/CPI of 8.0 in 10-point scale or equivalent), CGPA/CPI 6.5 or 65% of marks in case of SC/ST/ differently-abled candidates.

Additional Eligibility Criteria for Admission into PhD Programme (Part Time PhD Candidates):
